**Philip Benedict**

*Assistant Professor of History, Brown University*

A history of France's largest provincial city. It is the first to examine a single French community over the full course of the civil wars (1560-1600). Professor Benedict explores the rise and decline of Protestantism, the sociology of the faith, and the causes and chronology of the popular violence that began to disturb the city after 1560. Also discussed are the roots of the militant Catholic movement of the Holy League and the first signs of the renewal of Catholic religious life visible amid the agitation of the league.
